# I. STATEMENT OF THE CASE

Petitioner requests reargument from the February 23, 2022, decision of this Honorable Court affirming the Superior Court that had affirmed the sentencing decision of the Court of Common Pleas, Criminal Trial Division of Philadelphia County. The Majority Decision, Concurring Decision and Dissenting Decision are collectively attached as Exhibit A.

# II. REASONS FOR GRANTING REARGUMENT

This Honorable Court affirmed the Superior Court's affirmance of the 50 year to life sentence imposed by the sentencing court on Petitioner Michael Felder. Mr. Felder challenged that sentence to this Court as a *de facto* life sentence banned by Miller v. Alabama, 567 U.S. 460 (2012), Montgomery v. Louisiana, 577 U.S. 190 (2016), and Commonwealth v. Batts, 163 A.3d 410 (Pa. 2017) ("Batts II"). Based upon its reading of Jones v. Mississippi, 141 S.Ct. 1307 (2021) this Court found the *de facto* life sentence question irrelevant and further concluded that Jones compelled overruling Batts II.

This Court's holding is incorrect for several reasons. As is clear from the record below, the sentencing judge intentionally imposed what she believed was a non-life sentence: 50 years to life; indeed, the prosecutor intentionally did not seek a life sentence (N.T. 10/24/14, 22) but believed 50 years was "half of a what I deem to be [a] life" sentence (N.T. 10/24/14, 50). Consistent with Miller, Montgomery and Jones, the sentencing court's rejection of a life without parole sentence was based on its view that Mr. Felder's crime reflected transient immaturity, not permanent

incorrigibility, or — as this Court required in Batts II — that the Commonwealth had not proved that Mr. Felder was incapable of rehabilitation. Id. at 455. Jones does not alter Miller's holding that a life without parole sentence imposed upon a youth (at the time of the offense) who is transiently immature is unconstitutionally disproportionate. And although the Eighth Amendment does not require that a court expressly find a youth's acts were the result of permanent incorrigibility, a sentence of life without parole is still prohibited if a court, rejecting that sentence, concludes - implicitly or explicitly - that the youth's crime reflected transient immaturity. For this reason, this Court should determine if the sentence meted out here was a de facto life sentence imposed upon a transiently immature juvenile, a question that went unaddressed by this Court's decision.

# III. ARGUMENT

Because A Life Without Parole Sentence Imposed On A Youth Whose Crime Reflects Transient Immaturity Remains Unconstitutionally Disproportionate Under Jones v. Mississippi, This Court Must Determine Whether Mr. Felder's 50 Year To Life Sentence Is An Unconstitutional *De Facto* Life Sentence.

At Michael Felder's resentencing, the prosecutor did not request a life sentence and the sentencing judge did not impose a life sentence. The prosecutor requested what she believed to be was a half of a life sentence, 50 years to life. The sentencing court went along with that request, agreeing that a non-life sentence of 50 years to life was appropriate. Jones v. Mississippi, 141 S.Ct. 1307 (2021) gave broad discretion to the judge in sentencing a juvenile for murder but affirmed the constitutionally mandated holding of Miller and Montgomery that even when discretionary, a life without parole sentence may not be imposed upon a youth whose crime reflects transient immaturity. In its affirmance, this Court did not address the question it must: whether a 50 years to life sentence is an unconstitutionally disproportionate de facto life without parole sentence when imposed upon a transiently immature youth.

The United States Supreme Court in <u>Jones</u> upheld the broad discretion of a sentencing judge when sentencing a juvenile for murder. <u>Jones</u> rejected the argument that <u>Miller</u> or <u>Montgomery</u> set forth any requirement, explicit or implicit, that the sentencing judge must make a factual determination about the juvenile's permanent incorrigibility. This Court in <u>Felder</u> appropriately read that limited nature of <u>Jones</u>' holding:

[T]he [United States Supreme] Court granted certiorari in Jones to consider whether a sentencer who imposes a life-without-parole sentence must make a separate factual finding of permanent incorrigibly, or at least provide an on-the-record sentencing explanation with an implicit finding of permanent incorrigibility. . . Upon its review, the Jones Court concluded that "Miller Montgomery squarely rejected such а requirement." Id. at 1314.

# Commonwealth v. Felder, slip opinion at 14.

While it rejected any factfinding by the sentencing judge in imposing a life without parole sentence, the Supreme Court in <u>Jones</u>, reaffirmed its holdings in both <u>Miller v. Alabama</u>, 567 U.S. 460 (2012) and <u>Montgomery v. Louisiana</u>, 577 U.S. 190 (2016): "The Court's decision

today carefully follows both <u>Miller</u> and <u>Montgomery</u>." <u>Jones</u>, 141 S.Ct. at 1321 Of particular relevance to the instant matter, <u>Jones</u> explicitly affirmed <u>Montgomery</u>'s holding that it would be unconstitutional to sentence a juvenile whose crime was a result of transient immaturity to a term of life imprisonment without parole:

"That <u>Miller</u> did not impose formal factfinding requirement does not leave States free to sentence a child whose crime reflects transient immaturity to life without parole. To the contrary, <u>Miller</u> established that this punishment is disproportionate under the Eighth Amendment." 577 U.S. at 211, 136 S.Ct. 718.

<u>Jones</u>, 141 S.Ct. at 1315, n. 2 (quoting <u>Montgomery</u>, 577 U.S. at 211).

Thus, while <u>Jones</u> unequivocally declined to impose a formal or informal fact finding by the sentencing judge concerning incorrigibility, it also unequivocally held that it remains a violation of the Eighth Amendment to impose a life without parole sentence on youths whose crimes reflect transient immaturity. <u>Id.</u> The question presented by this case, which this Court failed to address in its ruling, is not whether the sentencing court erred in failing to make a finding of permanent incorrigibility, but whether a discretionary life without parole sentence

can be imposed upon a juvenile whose crime reflects transient immaturity. <u>Jones</u>, <u>Montgomery</u>, and <u>Miller</u> plainly hold that such a sentence violates the Eighth Amendment.

Because the Eighth Amendment is violated by imposition of a life sentence upon a juvenile whose crime reflects transient immaturity, the Eighth Amendment would similarly be violated by a de facto life sentence imposed upon a juvenile whose crime reflects transient immaturity. The initial briefs presented by both of the parties in this Court reflect a discussion of that issue, an issue this Court found unnecessary to address because of its incorrect reading of Jones. Appellant contended that a de facto life sentence is any sentence with a minimum of 20-25 years. Appellee contended that a *de facto* life sentence is any sentence with a minimum of 40 years. At oral argument Justices Wecht and now Chief Justice Baer suggested that the *de facto* life sentence line was at 35 years or more - in accordance with the post-Miller mandatory sentencing scheme established by 18 Pa.C.S.A. § 1102.1. The de facto life question was not addressed directly by any of the Felder opinions, but it must be. Jones does not relieve this Court from addressing this question to ensure

that Mr. Felder is not in fact serving an unconstitutional sentence.

This Court's expansive reading of Jones also caused it to conclude that Batts II should be abrogated. See Commonwealth v. Felder, slip opinion at 2. In Batts II, this Court set forth what it considered appropriate procedures for the sentencing of children convicted of firstdegree murder in order to comply with the mandates of Miller and Montgomery. This Court's broad authority to establish rules for Pennsylvania sentencing practice and procedure permits this Court to go beyond the floor established by the Federal Constitution. The Jones Court, bound by prior precedent, explicitly acknowledged states' authority to create additional sentencing protections. Jones, 141 S.Ct. at 1322-23 ("Under our precedents, this Court's more limited role is to safeguard the limits imposed by the Cruel and Unusual Punishments Clause of the Eighth Amendment.").

[O]ur holding today does not preclude the States from imposing additional sentencing limits in cases involving defendants under 18 convicted of murder. States may categorically prohibit life without parole for all offenders under 18. Or States may require sentencers to make extra factual findings before sentencing an offender

under 18 to life without parole. Or States may direct sentencers to formally explain on the record why a life-without-parole sentence is appropriate notwithstanding the defendant's youth. States may also establish rigorous proportionality or other substantive appellate review of life-without-parole sentences.

Id. at 1323.

In <u>Jones</u>, the Court reasoned that:

When a new substantive rule of constitutional law is established, this Court is careful to limit the scope of any attendant procedural requirement to avoid intruding more than necessary upon the States' sovereign administration of their criminal justice systems." See Ford v. Wainwright, 477 U.S. 399, 416–417, 106 S.Ct. 2595, 91 L.Ed.2d 335 (1986) ("[W]e leave to the State[s] the task of developing appropriate ways to enforce the constitutional restriction upon [their] execution of sentences").

<u>Id.</u> at 1315, n. 2, (quoting <u>Montgomery</u>, 577 U. S. at 211).

The procedural protections set forth in <u>Batts II</u> were to provide a framework to determine the subclass of juvenile offenders who are ineligible to receive a life sentence. This is a subclass of juveniles whose crimes reflect transient immaturity, as explicitly defined in <u>Montgomery</u> in ruling <u>Miller</u> to be retroactive under <u>Teague v. Lane</u>, 489 U.S. 288

(1989). Indeed, absent a determination that Miller created a subclass of juvenile offenders for whom a particular punishment was no longer constitutional under the Eighth Amendment, Miller could not be applied retroactively. Based upon Jones's reading of Miller and Montgomery, this subclass of juvenile offenders are still ineligible to receive a life sentence. Jones could not be clearer that even a discretionary life without parole sentence must still be assessed for unconstitutional disproportionality. Montgomery did not expand the substantive right articulated in Miller; it merely defined the subclass of youth ineligible for a life sentence as required by its retroactivity analysis.

The procedural protections this Court advanced in <u>Batts II</u> do not expand youth's substantive rights either; they are still required to protect the subclass of juveniles who are ineligible to receive a life without parole sentence (or a *de facto* life sentence) as held by both <u>Montgomery</u> and <u>Jones</u>. Because a discretionary life without parole sentence cannot be imposed upon a transiently immature youth, it is appropriate that this Court require under its rule making authority that the sentencing judge state on the record the reasons for its sentence and whether the child's

acts were the product of transient immaturity. Without this process, a reviewing court could not assess whether the life or *de facto* life without parole sentence was unconstitutional, or at very least, an abuse of the broad discretion the sentencing court is otherwise afforded.

These additional safeguards stem from this Court's exercise of its "constitutional authority . . . to set forth the manner in which resentencing will proceed in the courts of this Commonwealth." <u>Batts II</u>, 163 A.3d at 410 (citing Pa. Const. art. V, § 10 (c)). See also Commonwealth v. Edmunds, 586 A.2d 887, 894 (Pa. 1991) ("each state has the power to provide broader standards, and go beyond the minimum which is established by the federal Constitution") (citing Commonwealth v. Sell, 470 A.2d 457, 467 (Pa. 1983)); Commonwealth v. Johnson, 247 A.3d 981, 983 n.1 (Pa. 2021) (determining that this Court has power to establish rules governing practice and procedure that is broader than federal constitutional law). Because these procedures set forth by Batts II explicitly rely upon state constitutional authority to establish procedures to be followed in Pennsylvania Courts, they are not affected by the United States Supreme Court's decision in Jones; indeed,

they are entirely consistent with <u>Jones</u>.<sup>1</sup>

Hence, this Court is incorrect when it suggests, "[m]oving forward, the authority of a sentencing court to impose a life-without-parole sentence on a juvenile homicide offender is circumscribed only to the extent set forth in 42 Pa.C.S. § 9721(b) and 18 Pa.C.S. § 1102.1, and by Miller's command to 'consider the mitigating qualities of youth.' Miller, 567 U.S. at 476 (internal quotations and citation omitted)." Felder, slip opinion at 19-21 (footnote deleted). A judge while sentencing a juvenile homicide offender cannot find that offender's conduct was the result of

¹ Jones upheld the still valid rule of Montgomery's sorting requirement: a transiently immature youth cannot receive a life sentence. Batts II merely implemented that still valid rule. Justice Wecht in his dissent suggested that supplemental briefing on that issue might be appropriate. "Batts II is not a single-issue precedent of narrow applicability. It is a complex, multi-faceted decision, one that drew authority from numerous sources, establishing a series of procedural protections for juveniles. Before unilaterally deciding that no aspect of that complicated decision can remain, I would first consider the informed input of interested parties." Commonwealth v. Felder, \_\_\_A.3d\_\_\_, slip opinion at 8 (Wecht, J., dissenting). Justice Donohue similarly agreed that before Batts II is overruled, "the informed input of interested parties" should be obtained. Commonwealth v. Felder, \_\_\_A.3d\_\_\_, slip opinion at 2, n. 2 (Donohue, J., concurring). Reconsideration should also be granted to permit the parties to brief this issue.

transient immaturity and then sentence the offender to life without parole. That would not be constitutionally permitted any more than it would be permitted in a capital discretionary case to find that mitigators outweighed aggravators but nonetheless sentence the offender to death. Again, citing Montgomery, Jones held, "[t]hat Miller did not impose a formal factfinding requirement does not leave States free to sentence a child whose crime reflects transient immaturity to life without parole. To the contrary, Miller established that this punishment is disproportionate under the Eighth Amendment.' 577 U.S. at 211, 136 S.Ct. 718." Jones, 141 S.Ct. at 1315, n. 2.

A life without parole sentence imposed upon a transiently immature youth is cruel and unusual punishment and unconstitutional under the Eighth Amendment. By imposing what she intended to be a non-life sentence upon Michael Felder, the sentencing judge found that his crime, though serious, was reflective of transient immaturity, as required by Miller and Montgomery. This Court should reconsider the instant decision so that it can determine the question presented here that it did not consider in its February 2022 decision: that a 50 years to life

sentence constituted a *de facto* life without parole sentence that could not constitutionally be imposed upon a juvenile whose crime reflects transient immaturity. This Court should grant reconsideration.

# IV. CONCLUSION

While <u>Jones v. Mississippi</u> held that fact-finding is not required when imposing a life without parole sentence, it did not overrule the holding in <u>Miller</u> and <u>Montgomery</u> that a life sentence may not be imposed upon a transiently immature youth. A *de facto* life sentence is similarly forbidden. This Court should grant reconsideration to address whether Mr. Felder's 50 years to life sentence is an unconstitutional sentence in violation of <u>Miller</u>, <u>Montgomery</u>, and <u>Jones</u>.

### **OPINION**

#### JUSTICE DOUGHERTY<sup>1</sup>

Over the past two decades, in a series of Eighth Amendment cases applying the Cruel and Unusual Punishments Clause,<sup>2</sup> the United States Supreme Court consistently has held that sentencing an offender who was under eighteen years old at the time of the crime raises special constitutional considerations. Of particular consequence in this line of cases were *Miller v. Alabama*, 567 U.S. 460 (2012), which prohibited mandatory life sentences for juvenile homicide offenders, and *Montgomery v. Louisiana*, 577 U.S. 190 (2016), which held *Miller* applied retroactively to cases on collateral appeal. In the wake of these decisions, hundreds of defendants who committed murder as a juvenile and were

imprisoned under Pennsylvania's former mandatory-life-without-parole sentencing scheme had to be resentenced.

For our part, in *Commonwealth v. Batts*, 163 A.3d 410 (Pa. 2017) ("*Batts II*"), we exercised "our constitutional power of judicial administration to devise a procedure for the implementation of the *Miller* and *Montgomery* decisions in Pennsylvania." *Id.* at 451 (internal quotations omitted). Among other things, we adopted a presumption against the imposition of a sentence of life without parole for juveniles and imposed on the Commonwealth the burden of proving, beyond a reasonable doubt, that a juvenile offender is incapable of rehabilitation. *See id.* at 459. We determined these procedures were necessary to effectuate what we believed then was the central mandate of *Miller* and *Montgomery*: that "for a life-without-parole sentence to be constitutionally valid, the sentencing court must find that the juvenile offender is permanently incorrigible and that rehabilitation would be impossible." *Id.* Still, even after establishing this comprehensive set of legal criteria to guide juvenile sentencings, other questions remained. We granted review in this case to consider one such issue: whether a discretionary term-of-years sentence may be so long as to amount to a *de facto* life sentence, thereby triggering the substantive and procedural protections afforded by *Miller* and its progeny.

Before we could resolve that issue, however, the High Court decided *Jones v. Mississippi*, \_\_\_\_ U.S. \_\_\_\_, 141 S.Ct. 1307 (2021), which severely narrowed the holdings of *Miller* and *Montgomery* as previously understood by many courts, including this one. Upon careful review of this new guidance, we are constrained to conclude our decision in *Batts II* has largely been abrogated. We further conclude *Jones* is dispositive of the issue presented here. As we will explain below, pursuant to the reasoning in *Jones*, even if a term-of-years sentence amounts to a *de facto* life sentence, *Miller* provides no viable avenue for relief. Accordingly, we affirm appellant's judgment of sentence.

#### I. Relevant Precedent

Before discussing the facts, we start with a review of the relevant precedent. In 2005, the United States Supreme Court began to place various constitutional limits on sentencing juveniles who had been convicted of serious criminal offenses.<sup>3</sup> First, in *Roper v. Simmons*, 543 U.S. 551, 578 (2005), it concluded the Eighth Amendment forbids capital punishment for murderers who were under eighteen at the time of their crimes. Next, in *Graham v. Florida*, 560 U.S. 48, 82 (2010), the Court held the Eighth Amendment prohibits life without parole for juvenile offenders who did not commit homicide. Then in *Miller* in 2012, the Court barred mandatory sentencing schemes for juveniles convicted of homicide, concluding such sentences violate the principle of proportionality inherent to the Eighth Amendment. *Miller*, 567 U.S. at 489.<sup>4</sup> Four years later, in *Montgomery*, the Court held *Miller* announced a substantive rule of constitutional law that applies retroactively to cases on collateral review. *Montgomery*, 577 U.S. at 212.

Our opinion in *Batts II* came on the heels of these decisions and the General Assembly's enactment of a new sentencing statute for juveniles convicted of first- and second-degree murder after June 24, 2012 — the day before *Miller* was decided. *See* 18

<sup>&</sup>lt;sup>3</sup> Much of the High Court's Eighth Amendment jurisprudence concerning juveniles is well-trodden territory for this Court, see *Batts II*, 163 A.3d at 431-41, so a brief summary will suffice to lay the necessary foundation.

<sup>&</sup>lt;sup>4</sup> In *Commonwealth v. Batts*, 66 A.3d 286 (Pa. 2013) ("*Batts I*"), our first post-*Miller* decision addressing the sentencing of juvenile homicide offenders, we rejected the argument that juveniles can never be sentenced to life without parole, noting that *Miller* itself did not require such a broad proscription. *See id.* at 296. Instead, we explained *Miller* requires only "that there be judicial consideration of the appropriate age-related factors set forth in that decision prior to the imposition of a sentence of life imprisonment without the possibility of parole on a juvenile." *Id.* We also found nothing to suggest "that Pennsylvania's history favors a broader proportionality rule than what is required by the United States Supreme Court." *Id.* at 299.

Pa.C.S. §1102.1(a), (c).<sup>5</sup> We began our analysis by addressing the appropriate level of scrutiny for appellate review of a non-mandatory sentence of life without parole imposed upon a juvenile. See Batts II, 163 A.3d at 434. This was critical, we explained, because the distinction between a claim challenging the discretionary aspects of a sentence, as opposed to its legality, "also encompasses matters of issue preservation, this Court's jurisdiction to decide the question presented, and the level of deference the reviewing court must give to the decision of the sentencing court." Id. Ultimately, after conducting an extensive review of the High Court's Eighth Amendment precedent, we resolved that "in the absence of the sentencing court reaching a conclusion . . . that the defendant will forever be incorrigible, without any hope for rehabilitation, a life-without-parole sentence imposed on a juvenile is illegal, as it is beyond the court's power to impose." *Id.* at 435. In other words, we interpreted the High Court's decisions in *Miller* and *Montgomery* as "permit[ting] the imposition of a life-without parole sentence upon a juvenile offender only if the crime committed is indicative of the offender's permanent incorrigibility; that the crime was not the result of the unfortunate yet transient immaturity endemic of all juveniles." Id. (internal quotations and citations omitted; emphasis in original); see also id. ("[F]or a sentence of life without parole to be proportional as applied to a juvenile murderer, the sentencing court must first find, based on competent evidence, that the offender is entirely unable to change.").

We reiterated this understanding when we proceeded to consider the legality of Batts's sentence *de novo*, and held it was illegal. Initially, we recognized there was "no question that the sentencing court thoroughly and completely reviewed the record and thoughtfully considered the testimony presented at the resentencing hearing" before

<sup>5</sup> We observed in *Batts II* that "the General Assembly has not passed a statute addressing the sentencing of juveniles convicted of first-[ or second-]degree murder pre-*Miller*[.]" *Batts II*, 163 A.3d at 445. This remains true today.

imposing a discretionary life-without-parole sentence. *Id.* at 437 (footnote omitted); *see also id.* at 424 (noting sentencing court "took into account the general factors in [S]ection 9721(b) of the Sentencing Code, the *Miller* factors and the factors identified in 18 Pa.C.S. §1102.1(d)") (footnote omitted).<sup>6</sup> Nevertheless, we held this was not enough to withstand

the general principle that the sentence imposed should call for total confinement that is consistent with section 9725 (relating to total confinement) and the protection of the public, the gravity of the offense as it relates to the impact on the life of the victim and on the community, and the rehabilitative needs of the defendant. The court shall also consider any guidelines for sentencing and resentencing adopted by the Pennsylvania Commission on Sentencing and taking effect under section 2155[.]

42 Pa.C.S. §9721(b). As for the *Miller* factors, we have identified those as

a juvenile's age at the time of the offense, his diminished culpability and capacity for change, the circumstances of the crime, the extent of his participation in the crime, his family, home and neighborhood environment, his emotional maturity and development, the extent that familial and/or peer pressure may have affected him, his past exposure to violence, his drug and alcohol history, his ability to deal with the police, his capacity to assist his attorney, his mental health history, and his potential for rehabilitation.

Batts I, 66 A.3d at 297 (internal quotations and citation omitted). Lastly, Section 1102.1(d) mandates that

[i]n determining whether to impose a sentence of life without parole under subsection (a), the court shall consider and make findings on the record regarding the following:

- (1) The impact of the offense on each victim, including oral and written victim impact statements made or submitted by family members of the victim detailing the physical, psychological and economic effects of the crime on the victim and the victim's family. A victim impact statement may include comment on the sentence of the defendant.
- (2) The impact of the offense on the community.
- (3) The threat to the safety of the public or any individual posed by the defendant.

<sup>&</sup>lt;sup>6</sup> Section 9721(b) of the Sentencing Code requires courts to adhere to

constitutional scrutiny. In our judgment, the sentencing court had "overlooked the main premise" of the High Court's juvenile sentencing jurisprudence and impermissibly overrode its repeated admonitions "that juvenile first-degree murderers are presumptively less culpable than their adult counterparts and, as such, should be sentenced differently." *Id.* at 437. Thus, notwithstanding the court's finding that Batts's crime was not the result of unfortunate yet transient immaturity, because the court also opined that "there remained a possibility that Batts could be rehabilitated[,]" we held a sentence of life in

(4) The nature and circumstances of the offense committed by the defendant.

- (6) Guidelines for sentencing and resentencing adopted by the Pennsylvania Commission on Sentencing.
- (7) Age-related characteristics of the defendant, including:
  - (i) Age.
  - (ii) Mental capacity.
  - (iii) Maturity.
  - (iv) The degree of criminal sophistication exhibited by the defendant.
  - (v) The nature and extent of any prior delinquent or criminal history, including the success or failure of any previous attempts by the court to rehabilitate the defendant.
  - (vi) Probation or institutional reports.
  - (vii) Other relevant factors.

18 Pa.C.S. §1102.1(d). As we have previously remarked, Section 1102.1(d) requires sentencing courts to consider some, though not all, of the *Miller* factors. *See Batts II*, 163 A.3d at 455 n.23.

<sup>(5)</sup> The degree of the defendant's culpability.

prison without the possibility of parole was illegally "disproportionate under *Miller* and *Montgomery*[.]" *Batts II*, 163 A.3d at 436, 439.

Our task in Batts II did not end there. We also recognized that "[d]espite the sentencing court's best efforts . . ., the lack of procedural safeguards resulted in it failing to properly apply the law to Batts'[s] resentencing." Id. at 451. Moreover, we observed that, at that time, there remained several hundred individuals in Pennsylvania prisons serving what we then believed were illegal life-without-parole sentences awaiting resentencing. See id. at 450. For those reasons, and because "[t]he General Assembly has not taken any appreciable steps to create a separate sentencing statute or to revise existing law so that it applies to juveniles convicted of first-[ or second-]degree murder prior to *Miller*[,]" we determined an "exercise of our constitutional authority [wa]s required to set forth the manner in which resentencing will proceed in the courts of this Commonwealth." Id. at 450-51. And since we sought to devise only a procedural framework for implementing Miller and Montgomery's substantive mandate, we reasoned that such power "falls squarely within our constitutional authority." Id. at 449; see PA. CONST. art. V, §10(c) ("The Supreme Court shall have the power to prescribe general rules governing practice, procedure and the conduct of all courts . . . if such rules . . . neither abridge, enlarge nor modify the substantive rights of any litigant.").

Pursuant to that power we approved a medley of protective procedural measures advanced by Batts and his *amici*. First, we determined "a faithful application of the holding in *Miller*, as clarified in *Montgomery*, requires the creation of a presumption against sentencing a juvenile offender to life in prison without the possibility of parole." *Id.* at 452. Second, based on "the definitive language used by" the High Court's precedents, we concluded "that to overcome the presumption against the imposition of a sentence of life without parole for a juvenile offender, the Commonwealth must prove that the juvenile is

constitutionally eligible for the sentence beyond a reasonable doubt." *Id.* at 455. Third, "[c]onsistent with the requirements of due process and [S]ection 1102.1(b)," we held that where the Commonwealth seeks to have the sentencing court impose a sentence of life without parole on a juvenile offender, "it must provide reasonable notice to the defendant prior to the sentencing hearing." *Id.* We anticipated that "the proper employment of these procedures w[ould] result in courts sentencing juveniles to life without parole in only the rarest of circumstances, as contemplated and prescribed by the United States Supreme Court." *Id.* at 457; see *id.* (expressing our intention to "curtail the imposition of illegal sentences of life without parole by sentencing courts").<sup>7</sup>

Even after *Batts II*, certain issues remained unresolved. We confronted one of those issues in *Commonwealth v. Machicote*, 206 A.3d 1110 (Pa. 2019). There, we held "that when a juvenile is exposed to a potential sentence of life without the possibility of parole the [sentencing] court must consider the *Miller* factors, on the record, prior to imposing a sentence." *Id.* at 1120. Failure to do so, we explained, renders the resulting sentence illegal — even in cases like Machicote's, where the defendant was not actually sentenced to life without parole. *See id*.

<sup>&</sup>lt;sup>7</sup> Several other procedural protections were also considered in *Batts II*. Notably, we rejected Batts's claim that expert testimony is constitutionally required in this context; disagreed that a jury must make the finding regarding a juvenile's eligibility to be sentenced to life without parole; and declined to permit appeals from the imposition of a sentence of life without parole to be taken directly to this Court. *See Batts II*, 163 A.3d at 455-57. But we did find it prudent to advise sentencing courts to "examine both the *Miller* factors and the [S]ection 1102.1(d) factors" in all cases, "regardless of whether the juvenile was convicted pre- or post-*Miller*." *Id*. at 455 n.23. Unlike with the other criteria discussed above, though, this directive did "not result from a review of the constitutionality of the statute." *Id*. at 458 n.25. Rather, it was based on "the policy determination and legislative intent embodied in [S]ection 1102.1 and the goal of uniformity in sentencing." *Id*. Importantly, we discerned "no impediment . . . to our instructing sentencing courts to use the new legislative provision as guidance without making it mandatory." *Id*.

Other gaps in the juvenile homicide offender sentencing framework have been filled by the Superior Court. For example, that court has extended aspects of our decision in *Batts II* to address situations that were not directly at issue in that case *See, e.g., Commonwealth v. Olds*, 192 A.3d 1188, 1197 (Pa. Super. 2018) (employing reasoning from *Batts II*, a first-degree murder case, to "hold that the Eighth Amendment permits imposition of [S]ection 1102(b)'s mandatory maximum term of life imprisonment for juveniles convicted of second-degree murder"); *accord Commonwealth v. Sesky*, 170 A.3d 1105, 1105-06 (Pa. Super. 2017). In other cases, the intermediate court has partially restricted our holdings in *Batts II* and *Machicote*. *See, e.g., Commonwealth v. Lekka*, 210 A.3d 343, 357 (Pa. Super. 2019) (distinguishing *Machicote* and finding no error in failure to consider *Miller* factors where the Commonwealth "did not seek, and the sentencing court did not impose, a life-without-parole sentence"); *Commonwealth v. White*, 193 A.3d 977, 983 (Pa. Super. 2018) (*Miller* factors must be considered "only in cases where the Commonwealth is attempting to meet its burden of overcoming the presumption against juvenile [life-without-parole] sentences").

Most relevant here, the Superior Court also has been at the forefront of addressing a wave of so-called *de facto* life sentence claims.<sup>8</sup> In 2018, a three-judge panel held as a matter of first impression that "a trial court may not impose a term-of-years sentence on a juvenile convicted of homicide if that term-of-years sentence equates to a *de facto* [life-without-parole] sentence unless it finds, beyond a reasonable doubt, that the juvenile is incapable of rehabilitation." *Foust*, 180 A.3d 433. Although the panel "decline[d] to draw a bright line . . . delineating what constitutes a *de facto* [life-without-parole] sentence and

<sup>&</sup>lt;sup>8</sup> Some courts define a *de facto* life sentence as "one that exceeds the defendant's life expectancy." *Adams v. State*, 188 So.3d 849, 851 (Fla. Dist. Ct. App. 2012). Generally speaking, we have no trouble concluding "[t]here are certain term-of-years sentences which clearly constitute *de facto*" life sentences — for instance, "a 150-year sentence." *Commonwealth v. Foust*, 180 A.3d 416, 438 (Pa. Super. 2018).

what constitutes a constitutional term-of-years sentence[,]" it held the inquiry must be informed by "consider[ing] the sentence for each individual crime separately and not [in] the aggregate[.]" *Id.* at 438, 441. Not long after, a different panel determined the "key factor in considering the upper limit of what constitutes a constitutional sentence" is "whether there is 'some meaningful opportunity to obtain release based on demonstrated maturity and rehabilitation." *Commonwealth v. Bebout*, 186 A.3d 462, 468 (Pa. Super. 2018), *quoting Graham*, 560 U.S. at 75. Using that standard, the Superior Court has approved a range of lengthy term-of-years sentences as constitutional. *See, e.g., Commonwealth v. Anderson*, 224 A.3d 40, 47 (Pa. Super. 2019) (50 years to life); *White*, 193 A.3d at 986 (35 years to life); *Bebout*, 186 A.3d at 469-70 (45 years to life); *Foust*, 180 A.3d at 438 (60 years to life, aggregated from two 30-years-to-life sentences).

# II. Facts & Procedural History

Having set forth the legal context in which the present appeal arose, we now return to the facts and procedural history. One summer day in 2009, when he was seventeen-and-a-half years old, appellant was playing in a pick-up basketball game with Andrew Williams at an outdoor court in Philadelphia. The pair were matched against brothers Jarrett and Malcolm Green. Shortly into the game, appellant's style of play became aggressive. Eventually, an argument ensued after Williams refused to hand the ball over to the Greens. Appellant walked to the sideline and removed a .380 semiautomatic handgun from his gym bag. He then shot Malcolm in the head before shooting Jarrett in the stomach and leg. Only Malcolm survived.

In 2012, a jury convicted appellant of first-degree murder and aggravated assault for his role in shooting the Greens. Pursuant to the then-applicable mandatory sentence for first-degree murder, which also applied to juveniles, appellant was sentenced to life

imprisonment without the possibility of parole. See 18 Pa.C.S. §1102(a)(1) (superseded as applied to juveniles by 18 Pa.C.S. §1102.1).

The Superior Court vacated appellant's judgment of sentence two years later. By that time, both *Miller* and *Batts I* had been decided. And since appellant's judgment of sentence was not yet final, the Superior Court determined he was entitled to the benefit of those rulings and to consideration of the *Miller* factors before being resentenced, and remanded the case for such proceedings. *See Commonwealth v. Felder*, 2148 EDA 2012, 2014 WL 10919377 (Pa. Super. June 27, 2014) (unpublished memorandum).

On October 24, 2014, the trial court held a second sentencing hearing. Appellant asserted the murder was an impulsive act that was the product of his undeveloped juvenile brain. He maintained that, because his brain was still developing at the time, he presented a greater opportunity for rehabilitation than would an adult who committed the same crime. Appellant offered evidence to demonstrate he already had used prison as an opportunity to rehabilitate and to better himself. For example, while incarcerated, appellant obtained his high school diploma and participated in therapeutic sessions with a violence prevention counselor. He also submitted testimony from his mother and a letter from his cousin.

The court considered the record — including, *inter alia*, presentence memoranda, psychological reports, victim impact statements, and school records — as well as the parties' arguments and evidentiary presentations, and the court's own "very lengthy contemporaneous notes taken during both the trial of this case and during the initial sentencing proceeding." Notes of Testimony ("N.T."), 10/24/2014, at 51. The court also contemplated, "on the record, every one of the twelve factors for a [c]ourt to consider before sentencing a juvenile for first-degree murder as enumerated in *Miller* and *Batts* [*I*.]" Sentencing Court Op., 2/18/2016, at 5; *accord* N.T. 10/24/2014 at 51-52. Based on that

wide-ranging review, the court found the facts and circumstances of appellant's crime necessitated a lengthy sentence. See N.T. 10/24/2014 at 53-54 (noting there were two victims and additional crimes charged; "to not take those facts into consideration now would be to denigrate the serious nature of the crimes [appellant] committed against both victims"). Accordingly, the court imposed a discretionary 50-years-to-life sentence for appellant's first-degree murder conviction.

On appeal to the Superior Court, appellant challenged the legality of his sentence, arguing "a 50-year minimum sentence is a *de facto* life sentence." *Commonwealth v. Felder*, 660 EDA 2015, 2017 WL 6505643 at \*2 (Pa. Super. Dec. 20, 2017) (unpublished memorandum). The panel found appellant's support for that position to be lacking. First, although appellant portrayed a 2012 United States Sentencing Commission Preliminary Quarterly Data Report as demonstrating that 470 months is considered a life sentence for purposes of federal law, the panel reviewed the same report and concluded the figure was nothing more than a nonbinding "statistic out of context." *Id.* at \*3.<sup>10</sup> Similarly, after looking to cases from other states that have addressed this issue, the panel lamented

<sup>&</sup>lt;sup>9</sup> Appellant additionally asserted *Miller* invalidated Pennsylvania's first-degree murder sentencing scheme, meaning he could be sentenced pursuant to the third-degree murder statute only. Although this Court had previously rejected that precise claim, *see Batts I*, 66 A.3d at 293-96, appellant argued it should be considered anew in light of *Montgomery*. The Superior Court declined appellant's invitation to reconsider the issue, finding he had failed to support the contention with substantive analysis or discussion. *See Felder*, 2017 WL 6505643 at \*5.

<sup>&</sup>lt;sup>10</sup> Other Superior Court panels have likewise struggled to determine what constitutional significance, if any, these types of statistics may hold in the analysis. *See, e.g., Bebout,* 186 A.3d at 469 (remarking "it is not at all discernable which statistics [courts] can rely on to predict life expectancy in specific cases" and expressing concern that the use of such data to govern *de facto* life sentence claims would "create a myriad of new questions without any easy answers, sending us down a constantly evolving rabbit hole from which we may never escape as more and more data arrives").

that it uncovered no "clear resolution," only "great disparity in approach and interpretation of the dictates of *Miller* . . . demonstrat[ing] the difficulty of the problem." *Id*.

In the absence of clear binding authority, the panel returned to the core holding of *Miller*, which prohibited only those sentencing schemes that prescribe mandatory life sentences without parole. The panel explained that, on its face, *Miller* "does not directly apply" to appellant's claim, *i.e.*, a challenge to a lengthy, but discretionary, term-of-years sentence. *Id.* at \*4; see also id. ("Miller did not address a situation . . . wherein a juvenile defendant was given a significant sentence upon the discretion of the trial court"); id. ("Miller takes no stand on claims of *de facto* life sentences"). It therefore concluded "that when a juvenile convicted of homicide has been subjected to a discretionary sentence that may approach, but does not clearly exceed life expectancy, that sentence does not run afoul of *Miller*." *Id.* Applying that rule to appellant's case, the panel detected no Eighth Amendment problem with his sentence. Although the 50-year minimum term may appear "significant" since it precludes appellant from seeking parole until he is 68 years old, the panel nevertheless found it constitutional because it "was the result of an individualized and discretionary sentencing hearing[.]" *Id.* 

Appellant sought allowance of appeal in this Court, and we granted discretionary review limited to a single question:

Does not a sentence of 50 years to life imposed upon a juvenile constitute a *de facto* life sentence requiring the sentencing court, as mandated by this Court in *Commonwealth v. Batts*, 163 A.3d 410 (Pa. 2017) ("*Batts II*"), [to] first find permanent incorrigibility, irreparable corruption or irretrievable depravity beyond a reasonable doubt.

Commonwealth v. Felder, 187 A.3d 909 (Pa. 2018) (per curiam). This issue presents a question of law over which we exercise a de novo standard and plenary scope of review. Batts II, 163 A.3d at 435.

## III. Analysis

After the parties briefed and argued the issue upon which we granted review, the Supreme Court decided *Jones*. Because our review of that decision leads us to conclude it is dispositive here, we dispense with our usual practice of recounting the parties' arguments and proceed directly to our analysis.<sup>11</sup>

For the last few years, there has been widespread "disagreement in state and federal courts about how to interpret *Miller* and *Montgomery*[.]" *Jones*, 141 S.Ct. at 1313; *Batts II*, 163 A.3d at 458 n.26 (discussing different approaches). To create clarity and resolve the split, the Court granted *certiorari* in *Jones* to consider whether a sentencer who imposes a life-without-parole sentence must make a separate factual finding of permanent incorrigibility, or at least provide an on-the-record sentencing explanation with an implicit finding of permanent incorrigibility. *See Jones*, 141 S.Ct. at 1313. Upon its review, the *Jones* Court concluded that "*Miller and Montgomery* squarely rejected such a requirement." *Id.* at 1314.

Taking *Miller* first, the *Jones* Court clarified that it "mandated 'only that a sentencer follow a certain process — considering an offender's youth and attendant characteristics — before imposing' a life-without-parole sentence." *Id.* at 1314, *quoting Miller*, 567 U.S. at 483. According to the Court, such a discretionary "procedure ensures that the sentencer affords individual consideration to, among other things, the defendant's chronological age and its hallmark features." *Id.* at 1316 (internal quotations and citation

<sup>&</sup>lt;sup>11</sup> After *Jones* was decided, we directed the parties to address "its impact on the issue presented in this appeal." Order, 6/22/2021. In his response, appellant argues *Jones* "has no impact on Pennsylvania law" and maintains that "the sentencing procedures this Court set up in *Batts II* remain fully intact[.]" Appellant's Supplemental Brief at 1, 5. The Commonwealth, represented by the Philadelphia District Attorney's Office, adopts the same position. *See* Appellee's Supplemental Brief at 4 (asserting *Jones* "is not material to the question before this Court"); *see id.* at 5 (suggesting the "procedures this Court adopted in *Batts II* were not compelled by the Eighth Amendment").

omitted); see *id.* (stating non-mandatory sentencing schemes permit sentencers to "consider the murderer's diminished culpability and heightened capacity for change") (internal quotations and citation omitted). In support of this reading of *Miller*, the *Jones* Court found it significant that *Miller* "repeatedly described youth as a sentencing factor akin to a mitigating circumstance." *Id.* at 1315. This characterization, the *Jones* Court reasoned, reflects the fact that "permanent incorrigibility is not an eligibility criterion akin to sanity or lack of intellectual disability." *Id.* Rather, *Miller* merely "followed the Court's many death penalty cases and required that a sentencer consider youth as a mitigating factor when deciding whether to impose a life-without-parole sentence," but it "did not require the sentencer to make a separate finding of permanent incorrigibility before imposing such a sentence." *Id.* at 1316; *see id.* ("*Miller* cited *Roper* and *Graham* for a simple proposition: Youth matters in sentencing. And because youth matters, *Miller* held that a sentencer must have discretion to consider youth before imposing a life-without-parole sentence[.]").

As for *Montgomery*, the *Jones* Court bluntly declared that it "did not purport to add to *Miller*'s requirements." *Id.* To bolster this position, the Court noted it granted *certiorari* in *Montgomery* "not to consider whether the rule announced in *Miller* should be expanded, but rather simply to decide whether *Miller*'s holding is retroactive to juvenile offenders whose convictions and sentences were final when *Miller* was decided." *Id.* at 1317 (internal quotations and citation omitted). Thus, the Court found unpersuasive Jones's reliance "on language in *Montgomery* that described *Miller* as permitting life-without parole sentences only for those whose crimes reflect permanent incorrigibility, rather than transient immaturity." *Id.* (internal quotations omitted). Moreover, the Court emphasized that *Montgomery* "flatly stated that '*Miller* did not impose a formal factfinding requirement'

and that 'a finding of fact regarding a child's incorrigibility . . . is not required." *Id.* at 1314-15, *quoting Montgomery*, 577 U.S. at 211.

We distill the following holdings from *Jones*. First, "a separate factual finding of permanent incorrigibility is not required before a sentencer imposes a life-without-parole sentence on a murderer under 18." *Id.* at 1318-19. Second, "an on-the-record sentencing explanation . . . is not required by or consistent with *Miller*." *Id.* at 1320. Although "States may require sentencers to make extra factual findings before sentencing an offender under 18 to life without parole" or "direct sentencers to formally explain on the record why a life-without-parole sentence is appropriate notwithstanding the defendant's youth[,]" the federal constitution "does not demand those particular policy approaches." *Id.* at 1323. In short, "[i]n a case involving an individual who was under 18 when he or she committed a homicide, a State's discretionary sentencing system is both constitutionally necessary and constitutionally sufficient." *Id.* at 1313 (emphasis added).<sup>12</sup>

1:

Justice Thomas authored a concurring opinion which principally took aim at the Court's treatment of *Montgomery*. He argued that "[r]ather than accept what was plainly the case — that *Miller* was procedural, not watershed, and thus not retroactive — *Montgomery* proceeded to 'rewrite' it into a substantive rule." *Id.* at 1325 (Thomas, J., concurring) (internal quotations and citation omitted). This supposed error, in Justice Thomas's view, forced the *Jones* majority to "labor[] mightily to avoid confronting the tension between *Miller* and *Montgomery*[.]" *Id.* at 1328. In this regard, the *Jones* majority held that, to the extent *Montgomery* "is in tension with the Court's retroactivity precedents that both predate and post-date *Montgomery*, those retroactivity precedents — and not *Montgomery* 

In a blistering dissent joined by Justices Breyer and Kagan, Justice Sotomayor forcefully argued the *Jones* Court was retreating from *Montgomery*'s reading of *Miller*. See *Jones*, 141 S.Ct. at 1328 (Sotomayor, J., dissenting) (asserting the decision "guts" *Montgomery*'s interpretation of *Miller* and "reduces *Miller* to a decision requiring just a discretionary sentencing procedure where youth [is] considered") (internal quotations and citation omitted). In fact, Justice Sotomayor pointed to *Batts II* and implied that this Court, unlike the *Jones* majority, had properly recognized *Miller* "requires far more than mere consideration of an offender's age[.]" *Id.* at 1334, *quoting Batts II*, 163 A.3d at 433. In any event, because the *Jones* majority expressly declared its decision "does not overrule *Miller* or *Montgomery*[,]" Justice Sotomayor urged courts "to continue applying those decisions faithfully." *Id.* at 1337 (internal quotations and citation omitted).

Before considering how *Jones* impacts the issue presented, we revisit our decision in *Batts II*. In that case we found it necessary to adopt a number of procedural protections for purposes of sentencing juvenile murderers. We did so "to effectuate the mandate of *Miller* and *Montgomery*[.]" *Batts II*, 163 A.3d at 415. But *Jones* has fundamentally altered our understanding of those cases. The entire procedural framework we devised in *Batts II* was built on our assumption that "for a life-without-parole sentence to be constitutionally valid, the sentencing court must find that the juvenile offender is permanently incorrigible and that rehabilitation would be impossible." *Id.* at 459. Yet, *Jones* unequivocally dictates that a "finding of permanent incorrigibility is not required before a sentencer imposes a life-without-parole sentence on a murderer under 18." *Jones*, 141 S.Ct. at 1318-19. In the face of this conflict, it's no contest: "this Court is bound by the determinations of the United States Supreme Court on issues of federal law, including the construction and interpretation of the federal constitution." *Hall v. Pennsylvania Bd. of Prob. & Parole*, 851 A.2d 859, 863 (Pa. 2004) (citations omitted).

To reiterate, under the current state of Eighth Amendment law as expressed by Jones, "a State's discretionary sentencing system is both constitutionally necessary and constitutionally sufficient." Jones, 141 S.Ct. at 1313. A life-without-parole sentence for a juvenile murderer is thus constitutional, and hence no viable *Miller* claim exists, "so long as the sentence is not mandatory — that is, [] so long as the sentencer has discretion to consider the mitigating qualities of youth and impose a lesser punishment." *Id.* at 1314 (internal quotations and citations omitted). In *Batts II*, we interpreted *Montgomery* as "clarif[ying] that *Miller* requires far more than mere consideration of an offender's age prior

<sup>—</sup> must guide the determination of whether rules other than *Miller* are substantive." *Id.* at 1317 n.4. Justice Thomas took this statement to mean the Court was effectively overruling *Montgomery* "in substance but not in name." *Id.* at 1327; *see id.* (contending *Montgomery* "gave a good-for-one-ride ticket to a class of juvenile offenders, and its errors will never be repeated").

to imposing a life-without-parole sentence[.]" *Batts II*, 163 A.3d at 433. This interpretation led us to hold that "for a sentence of life without parole to be proportional as applied to a juvenile murderer, the sentencing court must first find . . . that the offender is entirely unable to change." *Id.* at 435; see *also id.* (expressing belief that "[t]he United States Supreme Court decisions that control in this matter unambiguously permit the imposition of a life-without-parole sentence upon a juvenile offender **only** if the crime committed is indicative of the offender's permanent incorrigibility") (emphasis in original). Our understanding in this regard, however, has been abrogated by the High Court's decision in *Jones*.<sup>13</sup>

Moreover, we are constrained to conclude that without a substantive constitutional mooring, the procedural protections we adopted in *Batts II* cannot stand in their current, judicially-created form. As we have observed, "the Pennsylvania Constitution clearly and unambiguously bestows upon this Court 'the power to prescribe general rules governing practice, procedure and the conduct of all courts[,]" but only if "such rules 'neither abridge, enlarge nor modify the substantive rights of any litigant[.]" *Id.* at 449, *quoting* PA. CONST. art. V, §10(c). The procedural protections we embraced in *Batts II* — more specifically, a presumption against life-without-parole sentences and a requirement that to overcome this presumption the Commonwealth bears the burden of proving the impossibility of rehabilitation beyond a reasonable doubt — were not intended to enlarge any substantive rights of juvenile homicide offenders. Instead, we repeatedly stressed throughout our opinion that we believed those protections were constitutionally necessary "to effectuate the mandate of *Miller* and *Montgomery*" by "ensur[ing] that life-without-parole sentences are meted out only to the rarest of juvenile offenders whose crimes reflect permanent

<sup>&</sup>lt;sup>13</sup> The same is true of our decision in *Machicote*, wherein we held that sentencing courts are "required to make a record of the *Miller* factors at sentencing." *Machicote*, 206 A.3d at 1120.

incorrigibility, irreparable corruption and irretrievable depravity." *Id.* at 415-16 (internal quotations and citations omitted); *see id.* at 452 ("a faithful application of the holding in *Miller*, as clarified in *Montgomery*, requires the creation of a presumption against sentencing a juvenile offender to life in prison without the possibility of parole"); *id.* at 455 ("Pursuant to . . . the definitive language used by the Supreme Court, we conclude that to overcome the presumption against the imposition of a sentence of life without parole for a juvenile offender, the Commonwealth must prove that the juvenile is constitutionally eligible for the sentence beyond a reasonable doubt."). However, *Jones* now instructs that, for purposes of the Eighth Amendment, "a State's discretionary sentencing system is . . . constitutionally sufficient." *Jones*, 141 S.Ct. at 1313.

We are thus forced to conclude the sentencing procedures we adopted in *Batts II* "do not carry the protections of the Eighth Amendment[.]" *Commonwealth v. DeJesus*, \_\_\_\_ A.3d \_\_\_\_, 2021 WL 4889071 at \*3 (Pa. Super. 2021) (*en banc*). And absent some constitutional impetus, those procedures are no longer the product of a proper exercise of this Court's authority over judicial administration, because they enlarge the substantive rights of juvenile homicide offenders beyond what *Miller*, as cabined by *Jones*, requires. *Cf.* PA. CONST. art. V, §10(c). Consequently, we are left with no choice but to dissolve those procedural requirements in *Batts II* that are not constitutionally required — namely, the presumption against sentencing a juvenile homicide offender to life without parole, and the imposition on the Commonwealth of the burden of proving beyond a reasonable doubt that the juvenile is permanently incorrigible.<sup>14</sup> Moving forward, the authority of a

<sup>&</sup>lt;sup>14</sup> The dissent, apparently believing we granted review to decide the "point at which [a term-of-years] sentence converts into the functional equivalent of a life sentence[,]" Dissenting Opinion at 4, charges us with going "beyond the issues presented for review[.]" *Id.* at 8. Respectfully, the dissent's premise is faulty. The question we actually agreed to consider, as phrased by appellant, is whether "a sentence of 50 years to life imposed upon a juvenile constitute[s] a *de facto* life sentence **requiring the sentencing court, as** 

sentencing court to impose a life-without-parole sentence on a juvenile homicide offender is circumscribed only to the extent set forth in 42 Pa.C.S. §9721(b) and 18 Pa.C.S.

mandated by this Court in [Batts II, to] first find permanent incorrigibility, irreparable corruption or irretrievable depravity beyond a reasonable doubt." Felder, 187 A.3d 909 (emphasis added). As appellant's claim is expressly tethered to our decision in Batts II, the dissent's argument we have improperly "inject[ed] consideration of [that] case" into our analysis, is untenable. Dissenting Opinion at 8-9.

In the alternative, the dissent says we should discontinue this case on the basis that "the analysis is not substantially prompted, or supported, by the parties' arguments." Dissenting Opinion at 6. Although the dissent acknowledges we afforded the parties an opportunity to file supplemental briefs addressing *Jones*, it implies this was insufficient "because our mandate to the parties for additional briefing did not mention *Batts II*[.]" *Id.* at 7. Again, this argument lacks any purchase since it is based on the dissent's truncated reading of the issue before us. Appellant baked consideration of *Batts II* directly into the question presented, and our supplemental briefing order instructed the parties to brief *Jones*'s "impact on the issue presented[.]" Order, 6/22/2021. Thus, the implication we are somehow acting unilaterally or without input from the parties, is not well taken.

At bottom, the issue we must decide, as framed by appellant, is whether he is entitled to relief under Batts II. Answering that question necessarily requires us to re-evaluate Batts II under Jones, which, the dissent concedes, "changed everything." Dissenting Opinion at 5. That the parties have refused to provide us with a fair appraisal of the High Court's intervening, binding decision is not a proper reason to dismiss the appeal. Cf. generally Commonwealth v. Brown, 196 A.3d 130, 149 (Pa. 2018) ("[I]f the 'power' of a court amounts to nothing more than the power to do exactly what the parties tell it to do, simply because they said so and without any actual merits review, it is not judicial power at all. It is a restriction on power.") (internal quotations and citation omitted; emphasis in original). Nor does the dissent's assertion of mootness warrant dismissal. Even if we agreed with that characterization (we do not), this case would almost surely qualify for an exception. See, e.g., Pap's A.M. v. City of Erie, 812 A.2d 591, 600-01 (Pa. 2002) (alluding to the great-public-importance exception to the mootness doctrine, particularly in the face of a material lack of clarity in governing law). We crafted Batts II, so the responsibility naturally falls to us to clarify its viability following new governing federal law — and to do so with haste. Contrary to the dissent's protestations, we respectfully believe the present case is a proper vehicle for providing that clarification.

§1102.1, and by *Miller*'s command to "consider the mitigating qualities of youth." *Miller*, 567 U.S. at 476 (internal quotations and citation omitted). <sup>15</sup>

We turn, finally, to the purported *de facto* life sentence before us, and we again find that *Jones* controls. To put it simply, even if a 50-years-to-life sentence amounts to a *de facto* life sentence, "there is no *Miller* problem here." *United States v. Grant*, 9 F.4th 186, 197 (3rd Cir. 2021) (*en banc*). This is because *Miller*'s bar on mandatory life-without-parole sentencing regimes "is a prophylactic that entitles a juvenile homicide offender to a certain sentencing process, but not a particular sentencing outcome[.]" *Id.* at 193. Indeed, permanent incorrigibility is "not an eligibility criterion akin to sanity or a lack of intellectual disability[,]" rather it is "a sentencing factor akin to a mitigating circumstance." *Jones*, 141 S.Ct. at 1315. For that reason, *Miller* "mandated only that a sentencer follow a certain process — considering an offender's youth and attendant characteristics — before imposing a life-without-parole sentence." *Id.* at 1311 (internal quotations and citations omitted); *see also Grant*, 9 F.4th at 200 ("What matters for *Miller* purposes is whether the sentencer considered a juvenile homicide offender's youth and attendant characteristics before sentencing him or her to [life without parole].").

It logically and necessarily follows that if a discretionary sentencing scheme is constitutionally sufficient to permit the imposition of a life-without-parole sentence on a juvenile homicide offender, so too can a court impose a sentence that is something less than life without parole. This includes a term-of-years sentence that may amount to a *de* 

<sup>&</sup>lt;sup>15</sup> We recognize again that Section 1102.1 applies only to those juveniles "convicted after June 24, 2012." 18 Pa.C.S. §1102.1(a). In *Batts II*, we held that "for purposes of uniformity[,]" courts should examine the Section 1102.1(d) factors "regardless of whether the juvenile was convicted pre- or post-*Miller*." *Batts II*, 163 A.3d at 455 n.23. Although this directive did "not result from a review of the constitutionality of the statute[,]" we saw no problem with instructing sentencing courts "to use the new legislative provision as guidance without making it mandatory." *Id.* at 458 n.25. We likewise see no problem with reaffirming this non-binding requirement even after *Jones*.

facto life sentence. Stated differently, as long as the sentence was the product of a discretionary sentencing system that included consideration of the juvenile's youth, the Eighth Amendment is satisfied.

Here, the record makes clear that appellant received the constitutionally required procedure guaranteed by *Miller* and the Eighth Amendment. In resentencing appellant, the court had before it the parties' presentence memoranda, psychological reports, school records, and victim impact statements. It heard testimony from appellant and his mother and read a letter from his cousin. It considered the parties' arguments and evidentiary presentations made at the resentencing hearing. It reviewed "lengthy contemporaneous notes taken during both the trial of this case and during the initial sentencing proceeding." N.T. 10/24/2014 at 51. And it contemplated, "on the record, every one of the twelve factors . . . enumerated in *Miller* and *Batts* [*I*.]" Sentencing Court Op., 2/18/2016, at 5. This process was more than enough to meet the constitutional standard. *See Jones*, 141 S.Ct. at 1322 ("The resentencing in Jones's cases complied with [*Miller*] because the sentence was not mandatory and the trial judge had discretion to impose a lesser punishment in light of Jones's youth.").

### IV. Conclusion

Though we might prefer the more expansive view of *Miller* as seen through the lens of *Montgomery*, we cannot ignore that *Jones*'s interpretation is controlling as a matter of Eighth Amendment law. And because that decision abrogates our foundational understanding in *Batts II* that a juvenile homicide offender cannot constitutionally receive a sentence of life without parole unless he or she is proven to be permanently incorrigible, the procedural protections we adopted in that case to ensure that result are no longer tenable as an exercise of this Court's power of judicial administration. Therefore, when sentencing juvenile homicide offenders from this point forward, sentencing courts are

required to consider only the relevant sentencing statutes, which will guarantee that the sentencer considers the juvenile's youth and attendant characteristics as required by *Miller*. So long as the sentence imposed is discretionary and takes into account the offender's youth, even if it amounts to a *de facto* life sentence, *Miller* is not violated. Because the sentencing court in the present case followed this procedure, we affirm.<sup>16</sup>

Chief Justice Baer and Justices Todd and Mundy join the opinion.

We also note that *Jones* did not resolve whether a juvenile homicide offender may raise a viable as-applied Eighth Amendment claim challenging the disproportionality of a given sentence. *See Jones*, 141 S.Ct. at 1322 ("this case does not properly present — and thus we do not consider — any as-applied Eighth Amendment claim of disproportionality regarding Jones's sentence."), *citing Harmelin v. Michigan*, 501 U.S. 957, 996–1009 (1991) (Kennedy, J., concurring in part and concurring in judgment). As well, we stress that *Jones* "does not preclude the States from imposing additional sentencing limits in cases involving defendants under 18 convicted of murder." *Id.* at 1323. Our General Assembly remains free at any time to legislatively reimpose the *Batts II* procedures, or to enact any other appropriate measures. We merely conclude that we lack the power to impose such requirements because they are not constitutionally required.

<sup>&</sup>lt;sup>16</sup> The upshot is that an overwhelming majority of juvenile homicide offenders in this Commonwealth were resentenced long before the High Court's decision in *Jones. See* Pennsylvania Department of Corrections, Juvenile Lifers Information, https://www.cor.pa.gov/About%20Us/Initiatives/Pages/Juvenile-Lifers-Information.aspx (last visited Feb. 22, 2022) (indicating that out of a population of 521 juvenile homicide offenders, 474 have been resentenced, including 271 individuals who have been released on parole). ## **CONCURRING OPINION**

#### JUSTICE DONOHUE

I concur in the opinion of the learned Majority. I agree that *Jones v. Mississippi*, 141 S. Ct. 1307 (2021), requires that we reject Appellant's argument that a de facto life sentence is unconstitutional pursuant to the Eighth Amendment of the United States Constitution<sup>1</sup> and although not argued by the parties, it is necessary that we recognize that *Jones* removes the underpinning of our holding in *Commonwealth v. Batts*, 163 A.3d 410, 417 (Pa. 2017) ("*Batts II*"), which was predicated on now overruled Eighth Amendment jurisprudence. I write separately to recognize that this result is limited to what the Eighth Amendment requires. Today's decision does not foreclose further developments in the law as to the legality of juvenile life without parole sentences (or their

de facto equivalent as alleged here) under the Pennsylvania Constitution nor as to how appellate courts will review the discretionary aspects of such sentences.

Preliminarily, it is imperative to note that the only issue before the Court is whether the de facto life sentence was constitutional pursuant to the Eighth Amendment. In *Batts II*, we held that the United States Supreme Court's decisions in *Miller v. Alabama*, 567 U.S. 460 (2012), and *Montgomery v. Louisiana*, 577 U.S. 190 (2016), mandated, among other things, a presumption against sentencing a juvenile to life without the possibility of parole which may only be rebutted beyond a reasonable doubt by proof from the Commonwealth "that the juvenile offender is permanently incorrigible and thus is unable to be rehabilitated." *Batts II*, 163 A.3d at 459. *Jones* holds that "a separate factual finding of permanent incorrigibility is not required before a sentencer imposes a life-without-parole sentence on a murderer under [eighteen]." *Jones*, 141 S. Ct. at 1318–19. Clearly, the portions of *Batts II* relying on an Eighth Amendment mandate of a finding of a permanent incorrigibility have been abrogated.

However, the Majority's observation that "without a substantive constitutional mooring, the procedural protections we adopted in *Batts II* cannot stand in their current, judicially-created form" addresses only the constitutional mooring with respect to the Eighth Amendment.<sup>2</sup> It remains an open question whether any or all components of *Batts* 

<sup>&</sup>lt;sup>2</sup> I share Justice Wecht's observation that *Batts II* "is a complex, multi-faceted decision, one that drew authority from numerous sources, establishing a series of procedural protections for juveniles. Before unilaterally deciding that no aspect of that complicated decision can remain, I would first consider the informed input of interested parties." Dissenting Op. at 8. I depart from Justice Wecht's dissenting posture only because I find that affirming the sentence as constitutionally valid under the Eighth Amendment will channel advocacy towards the open questions identified within this opinion. Also, when allowance of appeal was granted, it was not improvident.

If remain in place with respect to the Pennsylvania Constitution's prohibition of "cruel punishments." In the predecessor decision to *Batts II*, we rejected a claim that Article I, Section 13 provides greater protection than the Eighth Amendment. However, the *Batts I* Court analyzed only the specific claim "that a categorical ban on the imposition of lifewithout-parole sentences on juvenile offenders is required by Article I, Section 13 of the Pennsylvania Constitution, which prohibits 'cruel punishments." *Commonwealth v. Batts*, 66 A.3d 286, 297 (Pa. 2013). The appellant's primary argument was "that this Court should expand upon the United States Supreme Court's proportionality approach, not that it should derive new theoretical distinctions based on differences between the conceptions of 'cruel' and 'unusual." *Id.* at 298.

Although we rejected the proffered argument, in my view, *Batts I* does not foreclose a departure from *Jones* with respect to the separate question of **how** a trial court determines whether a particular juvenile is the rare individual who should be incarcerated for life with no possibility of parole. Certainly, the Eighth Amendment requires only that the sentencing judge be given discretion to consider something less than that. "[A] State's discretionary sentencing system is both constitutionally necessary and constitutionally sufficient." *Jones*, 141 S. Ct. at 1313. *Batts I* says nothing regarding whether Article I, Section 13 is so limited.<sup>4</sup> *See Commonwealth v. Bishop*, 217 A.3d 833, 841 n.10 (Pa.

<sup>&</sup>lt;sup>3</sup> "Excessive bail shall not be required, nor excessive fines imposed, nor cruel punishments inflicted." PA. CONST. art. I, § 13.

<sup>&</sup>lt;sup>4</sup> In *Commonwealth v. Edmunds*, this Court rejected the "good faith" exception to the exclusionary rule as announced in *United States v. Leon*, 468 U.S. 897 (1984). *Commonwealth v. Edmunds*, 586 A.2d 887, 888 (Pa. 1991). We stated that "*Leon* ... departed from a long history of exclusionary rule jurisprudence," *id.* at 892, and described *Leon* as a "reinterpretation" that "differs from the way the exclusionary rule has evolved in Pennsylvania since the decision of *Mapp v. Ohio* in 1961 and represents a shift in

2019) ("It would be untenable for a court to decide an important state constitutional question as a precedential matter in the absence of any argumentation and without any analytical treatment on its own part of the departure question[.]"). Drawing on *Batts I*, there may be a theoretical difference between the "conceptions of 'cruel' and 'unusual'" for purposes of deciding that life sentences, or de facto life sentences for juveniles, are indeed unusual. 66 A.3d at 298. Absent directed advocacy on the separate question of whether the two provisions should be identical for all purposes, I distance myself from any implication that the issue has been resolved.

Finally, the foregoing discussion only speaks to the constitutionality of Felder's sentence. The constitutionality of that sentence opens the door to claims that such lengthy sentences, while not unconstitutional under the Eighth Amendment, nevertheless constitute an abuse of the trial court's discretion. The *Jones* Court was not concerned with the question of whether any individual juvenile's sentence was appropriate. Indeed, the Court explicitly suggested that further development in that arena is left to the States.

Importantly, like *Miller* and *Montgomery*, our holding today does not preclude the States from imposing additional sentencing limits in cases involving defendants under [eighteen] convicted of murder. States may categorically prohibit life without parole for all offenders under [eighteen]. Or States may require sentencers to make extra factual findings before sentencing an offender under [eighteen] to life without parole. Or States may direct sentencers to formally explain on the record why a life-without-parole sentence is

judicial philosophy from the decisions of the United States Supreme Court dating back to *Weeks v. United States.*" *Id.* at 897. Presently, the Majority cites the "blistering dissent" filed in *Jones* by Justice Sotomayor and joined by Justices Breyer and Kagan, which "forcefully argued the Court was retreating from *Montgomery's* reading of *Miller*." Majority Op. at 16 n.12. Those criticisms do not impact the *Jones* Court's holding. But the logical force of those arguments arguably matters a great deal insofar as the *Jones* Court's analysis of the United States Constitution is a factor in deciding whether this Court will follow when interpreting analogous provisions in the Pennsylvania Constitution.

appropriate notwithstanding the defendant's youth. States may also establish rigorous proportionality or other substantive appellate review of life-without-parole sentences. All of those options, and others, remain available to the States.

141 S. Ct. at 1323.

While the discretionary aspects of Felder's sentence are not at issue, I note that in *Batts I* then-Justice, now Chief Justice, Baer authored a concurring opinion highlighting the General Assembly's legislative response to *Miller*.

I write separately to note my belief that, for purposes of uniformity in sentencing, it would be appropriate for trial courts engaging in the task of resentencing under this circumstance to seek guidance in determining a defendant's sentence and setting a minimum term from the General Assembly's timely recent enactment in response to the U.S. Supreme Court's decision in *Miller*.

\* \* \*

If trial courts fail to take guidance from the recent legislative enactments, the minimum sentence imposed on any given juvenile before becoming eligible for parole could vary widely. One court could immediately parole an 18 year old offender. while another court could impose a 50 year minimum sentence on a 14 year old offender. While discretionary sentencing is a valid trial court function and Miller specifies that individual circumstances should be considered by judges sentencing juvenile murder offenders, given that the legislature is the policy-making body for our Commonwealth and has quickly responded to Miller indicating the minimum sentences it views as appropriate for different aged juvenile homicide offenders. I believe courts engaging in resentencing necessitated by the Miller decision, should look to the newly enacted statute for guidance without abrogating their discretion as appropriate in individualized cases

Batts I, 66 A.3d at 300 (Baer, J., concurring).

These observations may well impact not only how appellate courts review the discretionary aspects of these purported de facto life sentences, but also the constitutionality of those sentences under Article I, Section 13. In *Batts I*, we

acknowledged that the appellant argued that the trend of the high Court, as reflected in

cases like Miller, was to "view[] juveniles as a category as less culpable than adults[.]"

We responded that the appellant "does not acknowledge that there has been no

concomitant movement in this Court or in the Pennsylvania Legislature away from

considering murder to be a particularly heinous offense, even when committed by a

juvenile." 66 A.3d at 299. However, our General Assembly has spoken and the legislative

response to Miller is now even more relevant because, after Jones, the statute could

simply have been eliminated. Thus, its continued existence reflects an acknowledgement

by the General Assembly that juveniles should be treated differently. That policy

judgment may well be relevant to analyses of both the legality and discretionary aspects

of those sentences.

In 2005, the Supreme Court of the United States issued its first in a series of decisions interpreting the Eighth Amendment's Cruel and Unusual Punishments Clause as it applies to juveniles who have been convicted of serious criminal offenses. In that case, *Roper v. Simmons*, 543 U.S. 551, 578 (2005), the Supreme Court held that it is unconstitutional to impose the death penalty on individuals who committed their crime(s) as juveniles. Then, in *Graham v. Florida*, 560 U.S. 48, 82 (2010), the Court held that the Eight Amendment prohibits a juvenile convicted of a non-homicide offense from being sentenced to life imprisonment without the possibility of parole. The *Graham* Court explained that, although a "State is not required to guarantee" a juvenile's "eventual freedom," it must provide that juvenile with "some meaningful opportunity to obtain release based on demonstrated maturity and rehabilitation." *Id.* at 75.

The Supreme Court returned to this line of cases two years later in *Miller v. Alabama*, 567 U.S. 460 (2012). In *Miller*, the Court held that the Eighth Amendment forbids sentencing schemes that automatically mandate life without parole sentences for

juveniles convicted of murder, because the mandatory nature of the sentence precludes a sentencing court from considering the juvenile's age and the hallmark features of youth, most notably the continuing nature of brain development during those formative years. *Id.* at 477. Invoking its prior Eighth Amendment jurisprudence, the Supreme Court explained that, "given all we have said . . . about children's diminished culpability and heightened capacity for change, we think appropriate occasions for sentencing juveniles to this harshest possible penalty will be uncommon," particularly because of the difficulty "of distinguishing at this early age between 'the juvenile offender whose crime reflects unfortunate yet transient immaturity, and the rare juvenile offender whose crime reflects irreparable corruption." *Id.* at 479-80. In doing so, the *Miller* Court favorably cited *Graham*'s mandate that a juvenile must be given a reasonable opportunity for release from prison before his or her natural death, and extended this principle to certain juveniles convicted of murder. *Id.* at 479-80 (quoting *Graham*, 560 U.S. at 75).

Four years later, in *Montgomery v. Louisiana*, 577 U.S. 190 (2016), the Supreme Court held that *Miller* announced a substantive, rather than procedural, rule of law that applied retroactively to cases pending on collateral review. Of particular significance to that determination, the *Montgomery* Court emphasized that *Miller* "drew a line between children whose crimes reflect transient immaturity and those rare children whose crimes reflect irreparable corruption." *Id.* at 209. The Court further stressed that, even though "*Miller* did not impose a formal factfinding requirement[,]" states are not "free to sentence a child whose crime reflects transient immaturity to life without parole." *Id.* at 211.

These four rulings—particularly the latter two—created a paradigmatic shift in juvenile sentencing. In the wake of that shift, triggered by *Miller* and *Montgomery*, Pennsylvania courts were tasked with re-sentencing a significant number of juveniles convicted of murder whose life without parole sentences suddenly were unconstitutional.

At that time, there was no framework in place to sentence a juvenile convicted of first- or second-degree murder to anything other than life without parole. The Supreme Court left the creation of procedures to implement Miller and Montgomery to the states. Accordingly, in Commonwealth v. Batts, 163 A.3d 410 (Pa. 2017) (Batts II), this Court established a set of legal criteria to guide the bench and bar. We held that the trial court must operate initially under a presumption against sentencing a juvenile to life without parole. Id. at 451-52, 483-84. To overcome that presumption, we explained, the Commonwealth first must provide reasonable notice to the juvenile defendant that it intends to seek such a sentence. Id. at 477, 484. Then, the Commonwealth must prove, beyond a reasonable doubt, that the homicide was the product of the juvenile's permanent incorrigibility—meaning that the child is functionally incapable of rehabilitation—and was not an act of the juvenile's transient immaturity. Id. at 472-77. We added another requirement to the Batts II criteria in Commonwealth v. Machicote, 206 A.3d 1110, 1120 (Pa. 2019), wherein we held that, "when a juvenile is exposed to a potential sentence of life without the possibility of parole," the sentencing court must determine whether the Commonwealth has satisfied its burden, and it must "consider the Miller factors, on the record, prior to imposing a sentence."

Miller, Montgomery, Batts II, and Machicote, in tandem with subsequent legislative enactments, see e.g. 18 Pa.C.S. § 1102.1, provided lower courts with much of the framework necessary to sentence juvenile murderers in a constitutional manner. However, (at least) one important legal question lingered: when did a term of years function as a de facto life sentence without the possibility of parole? We had interpreted

In an earlier post-*Miller* case with the same name, this Court held that *Miller* did not preclude in all instances a life without parole sentence for juvenile offenders. *Commonwealth v. Batts*, 66 A.3d 286 (Pa. 2013). Thus, our 2017 decision is commonly referred to as "*Batts II*".

Miller and Montgomery to require an examination of the juvenile's mindset to ascertain whether the murder was the product of transient immaturity or whether it was the result of the child's permanent incorrigibility. If it was the latter, then the trial court could impose a life without parole sentence. However, if it was the former, then a trial court had to impose a term of years consistent with Graham and Miller's mandate that, although a "State is not required to guarantee" the juvenile's "eventual freedom," it must provide him or her with "some meaningful opportunity to obtain release based on demonstrated maturity and rehabilitation." Graham 560 U.S. at 75; Miller, 567 U.S. at 479-80. This requirement would prove illusory if, for instance, a trial court sentenced a juvenile to a minimum term of ninety years, which would eliminate any chance of the promised "meaningful opportunity" to be released from prison. As a minimum term of years increases, there eventually comes a point at which the sentence converts into the functional equivalent of a life sentence. But at what point does this conversion occur?

After oral argument in September of 2019, we were set to rule on that discrete question. It appeared that we were on the verge of establishing a near-complete model for sentencing juvenile murderers. Or, so we thought. Before we could issue an opinion, the Supreme Court of the United States granted *certiorari* in *Jones v. Mississippi*, 140 S. Ct. 1293 (2020), and we placed the instant case on hold. On April 22, 2021, the Supreme Court issued its decision in *Jones*, holding that, contrary to this Court's understanding, *Miller* did not require a sentencing court to make a separate factual finding that the juvenile's act was the product of his or her permanent incorrigibility before imposing a sentence of life without the possibility of parole. *Id.* at 1314-15. Instead, the Supreme Court construed *Miller* to prohibit only non-discretionary, automatic life without parole sentences on juveniles. A trial court may impose a life without parole sentence on a juvenile in a manner consistent with the Eighth Amendment, so long as the sentencing

procedure was discretionary in nature and afforded the sentencing court an opportunity to consider the juvenile's age in some substantive way. *Id.* at 1315-16.

All of our recent jurisprudence emanated from our understanding that *Miller* required a factual examination of the juvenile's act, with the sentencing court assessing whether that act was the product of transient immaturity or permanent incorrigibility. *Batts II* and *Machicote* provided a procedural framework to assist the court in making this determination. The present case was an opportunity to refine that framework even further. Then, *Jones* changed everything. The factual assessment that was the driving factor in our prior analyses is gone. So too is the notion that a life without parole sentence is available only after a rigorous process. After *Jones*, all that is required before imposing such a sentence is a discretionary process that includes age as a relevant sentencing factor. In other words, a life sentence in any case involving a murder committed by a juvenile does not *necessarily* violate the Constitution.

Jones has eliminated the need to devote any of our limited resources to this case. The moment that Jones was decided, any form of relief for Felder was foreclosed entirely. Moreover, the question posed by Felder was rendered unquestionably moot. As noted, he asks whether a fifty year to life imprisonment amounts to a de facto life sentence. This question falls at the end of the analytical line that the Supreme Court has erased. After Jones, the answer to Felder's question is simple: "it doesn't matter." A de facto life without parole sentence is not unconstitutional, regardless of whether Felder's murder was the product of transient immaturity or otherwise. There now exists no reason to attempt to ascertain when a term of years becomes a de facto life sentence. Accordingly, because the question that once appeared significant in our formerly developing jurisprudence now is moot and "not well-suited to facilitate our principal function of advancing the law,"

Commonwealth v. Tighe, 224 A.3d 1268, 1292 (Pa. 2020) (Wecht, J., concurring and dissenting), I would dismiss this case as improvidently granted.

The learned Majority presses forward anyway. Rather than deciding that Felder's question only existed in an Eighth Amendment landscape that has been razed to the ground and reconstructed in a wholly different form, the Majority instead decides that *Jones* "is dispositive of the issue presented here." Maj. Op. at 2. It is not. *Jones* does not dispose of the question of whether fifty years to life is a *de facto* life sentence without parole on the merits. To the contrary, *Jones* makes that question constitutionally irrelevant.

Mootness and constitutional irrelevancy aside, there is another compelling reason not to continue with this case: the analysis is not substantially prompted, or supported, by the parties' arguments. In their principal briefs, which predated *Jones*, both Felder and the Commonwealth focus upon the merits of the *de facto* life sentence question. Neither party had any reason to argue that *Miller*, *Montgomery*, or *Batts II* were wrongly decided, or that any of them should be reconsidered. No one at the time could have predicted that *Jones* would shatter the foundation upon which their arguments were based. Consequently, the parties' principal briefs shed no light on the state of the law post-*Jones* and are of little use to the instant discussion.

After *Jones* was decided, Felder filed an application asking this Court for permission to rest on his principal brief. The Commonwealth submitted a "no answer" letter to this Court. We denied Felder's application and, instead, on June 22, 2021, commanded the parties "to file supplemental briefs addressing the United States Supreme Court's decision in *Jones v. Mississippi*, \_\_\_ U.S. \_\_\_, 141 S. Ct. 1307 (2021), and its impact on the issue presented in this appeal." Order, 2/22/2021 (*per curiam*). Both parties complied with our directive and filed additional briefs. Neither was helpful.

Both Felder and the Commonwealth assert that *Jones* has no impact whatsoever on the outcome of this case. That being the state of the argumentation, it seems to me ill-advised to address the impact that *Jones* wrought upon Eighth Amendment jurisprudence in a case involving parties who believe it had none. I would await a case in which the respective parties willingly debate the key legal issue to reconstruct such an important aspect of the law.

The Majority does not just evaluate *Jones'* impact on our law. The Majority goes one step further and contemplates the post-Jones viability of Batts II. The Majority abrogates Batts II and finds "no choice but to dissolve those procedural requirements." Maj. Op. at 19. Neither party asks for a reevaluation of *Batts II*, and, more importantly, neither seeks an outright annulment of it. Once more, the principal briefs are not helpful, as the viability of Batts II could not have been at issue at that early point. supplemental briefing provides little more justification for such a sweeping ruling. This too is understandable, because our mandate to the parties for additional briefing did not mention *Batts II*, let alone direct the parties to address its ongoing viability. Nonetheless, Felder maintains throughout his supplemental brief that Batts II was an exercise of this Court's state constitutional authority and, thus, can survive *Jones'* holding. Commonwealth generally agrees with Felder that Batts II is an independent ruling from this Court that is not impacted by *Jones*. Stated otherwise, nobody asks this Court to overrule Batts II. To the contrary, both parties support its continued relevance.<sup>2</sup> In such circumstances, I would not relegate Batts II to the dustbin of history without full briefing from adversarial parties that have a vested interested in the outcome of this case. For the reasons stated above, Felder no longer has such an interest, because nothing we say

or do can afford him relief. Moreover, *Batts II* is not a single-issue precedent of narrow applicability. It is a complex, multi-faceted decision, one that drew authority from numerous sources, establishing a series of procedural protections for juveniles. Before unilaterally deciding that no aspect of that complicated decision can remain, I would first consider the informed input of interested parties.

I offer no opinion on the merits of any issue raised and resolved by the learned Majority. I do not dispute that each of those issues require this Court's attention. To be sure, it may be the case that the Majority correctly disposes of all relevant issues. The problem is that doing so in this case contravenes this Court's customarily restrained practice of waiting for cases in which the answers that we provide are responsive to the questions asked and supported by focused legal debate between the parties. Rather than using this case as a vehicle to go beyond the issues presented for review<sup>3</sup> and

Proof of the true character of this case is in the briefing. If reconsideration of *Batts II* was "baked" into the case, and tethered to our review, one would expect to see at least one of the parties argue that. No one does in either the initial briefing or in the post-*Jones* briefing. In fact, Felder neither questions *Batts II*, nor contemplates its continued existence. Rather, Felder sets forth the basic premises of that decision as the governing law, and then spends the vast majority of his argument urging this Court to define the point at which a sentence becomes *de facto* life sentence. The only fair reading of Felder's principal brief is consistent with my premise: that his question for this Court

The Majority takes issue with this characterization. The Majority claims that my premise is faulty, insisting that the question presented in this case necessarily implicates a comprehensive reconsideration of *Batts II*. See Maj. Op. at 19-20 n.14. Indeed, the Majority asserts that, "at bottom," Felder framed his claim as "whether he is entitled to relief under *Batts II*." However, this conclusion finds merit only if one focuses noncontextually upon the clause that is bolded by the Majority and by ignoring that which the Majority elects not to bold. The non-bolded language asks whether "a sentence of 50 years to life imposed upon a juvenile constitute[s] a *de facto* life sentence." *Felder*, 187 A.3d at 909 (Pa. 2018) (*per curiam*). The Majority now ignores that initial clause and reframes the case as one focusing merely upon whether *Batts II* remains good law. It is correct that Felder mentions *Batts II* in a subsequent clause, but that does not mean that we are free to ignore the primary clause and to construe the case however we may see fit. Felder's passing reference to *Batts II* as the prevailing law at the time in his question presented in no way "baked" a comprehensive review of that precedent into this case.

injecting consideration of a case that the lower courts did not anticipate and that the parties do not meaningfully address, and in the absence of any development of an independent basis to evaluate *Batts II*, the Court should allow the impact of *Jones* to be resolved in the normal course—with developed advocacy, reasoned opinions by the lower courts, and petitions for allowance of appeal. Restraint demands that we refrain from transforming this case beyond its legal circumstances into a vehicle to resolve even the

I would wait for an appropriate case in which the Court might address these important and complicated matters, and I would dismiss the instant appeal as improvidently granted. Because the Majority presses on in the face of these patent

most pressing questions.

deficiencies, I respectfully dissent.

focused entirely upon establishing the point in time at which the sentence violated (what we believed were) the mandates of *Miller* and *Montgomery*. Notably, the Majority points to no place in the initial briefing supporting its after-the-fact reconstruction of this case. The parties have never asked this Court to reconsider *Batts II*, either expressly or implicitly. It is the Majority that takes this case to places uncharted by the parties in their arguments.

The Majority also decides—again, on its own—that, even if the issue were moot, the case might "surely qualify" for an exception. Maj. Op. at 19-20 n.14. Respectfully, much like the rest of the Majority's analysis, this, too, is untethered to the parties' arguments, and a conclusion that I prefer to make only after those involved in the case have provided their respective positions.
