- Zubrow Fellowship Application Form
- Two essays on separate sheets
- Resume
- Law school transcript
- Three letters of recommendation, including from:
 - One law school professor
 - One current or former employer
 - One recommender of the applicant's choice
- Writing sample (no more than 10 double-spaced pages)

All materials, including the letters of recommendation, must be included with the application. Please send all application materials as a single PDF to **zubrow@jlc.org**.

The PDF file should be titled using the following format:

If your recommenders will not send the recommendation to you to include in your single submission, please direct them to email the file to zubrow@jlc.org and title the attachment using the following format: **LastName_FirstName_ZubrowRecommendation**
