The Center has a board designated fund referred as the "Zubrow Fund" which is reported as a separate line item on the foregoing Statement of Financial Position as Investments - board designated. The line item titled Investments on the foregoing Statement of Financial Position reflects the then current market value of the Center's unrestricted and undesignated investments, exclusive of the Zubrow Fund.

In previous financial statements, the Center has referred to the Zubrow Fund as an "endowment" that included the one million dollar (\$1,000,000) original corpus of the Zubrow Fund ("Zubrow Corpus") plus the accumulated income and investment returns of the Zubrow Corpus. The donor has confirmed that the Zubrow Fund is not restricted to any specific Center operations or

programming but has indicated a preference that the Zubrow Corpus and all income and investment returns of the Zubrow Fund, be used to support a portion or all of the annual cost to the Center to operate the Zubrow Fellowship Program. Nonetheless, the Center intends to manage the Zubrow Fund so that the current market value of the Zubrow Fund is one million dollars (\$1,000,000) or greater, at all times. In accordance with GAAP, the Center has accounted for the Zubrow Fund as board designated.
